- I. where the bid price is 20% or more below of the project cost gut to bid, the additional performance guarantee percentage. shall be incremented by 0.2% for every percentage of bid price below 20% of the project cost put to bid in addition to 1% of the bid price and this additional performance guarantee percentage shall be applied on the bid price;
  - II. The additional performance guarantee percentage shall be rounded *off* to the next lower percentage based on whether the decimal point of the percentage of bid price is below 0.5% or next higher percentage based on whether the decimal point of the percentage of bid price is 0.5% or more.

  - IV. An abnormally low bid is one in which the Bid price, in combination with other elements of the Bid, appears so low that it raises material concerns as to the capability of the Bidder to perform the contract at the offered price. Procuring Entity may, in such cases, seek written clarifications from the Bidder, including detailed price analyses of its Bid price in relation to scope, schedule, resource mobilization, allocation of risks and responsibilities, and any other requirements of the bid document. If, after evaluating the price analyses, the procuring entity determines that the Bidder has substantially failed to demonstrate its capability to deliver the contract at the offered price, the Procuring Entity may reject the Bid/Proposal. However, it would not be advisable to fix a normative percentage below the estimated cost, which would automatically be considered as an abnormally low bid.
- b. If more than one bid is quoted (decimal up to two numbers will be taken for all practical purposes), either at the estimated cost put to tender or less than the estimated cost put to tender, the tender accepting Authority will finalize the tender through a transparent lottery system, where all the concerned bidders/their authorized representatives, the concerned SE/EE of the concerned Division and Divisional Accounts Officer (DAO) will remain present.

If the rate quoted by the SC and ST Category Contractors comes to the rate quoted by the L 1 bidder (decimal up to two numbers will be taken for all practical purposes) after availing 10% price preference as per Para 2 of Works Department Resolution No. 27748 dated. 11.10.1977, the tender shall be finalized by the tender accepting authority through a transparent lottery system along with other categories of contractors.

- e. In case of S.C./S.T. candidates applied for in Annexure-III affidavit price preference as SC/ST candidate then he shall have to produce along with technical bid an affidavit before the Executive Magistrate that he has not taken more than three works on preference ground in the last financial year in any Govt. organization. Application in Annexure-III affidavit for price preference as SC/ST candidate without submission of the affidavit in technical bid shall be out rightly rejected during the Technical Evaluation.
- f. Bidder should not have been black listed by any Govt / Govt undertaking on bid submission date. Self-Declaration Certificate by the bidder in the form of affidavit is to be submitted.
- g. The intending bidders should submit their Original Affidavit(s) sworn before Notary Public or Executive Magistrate, as applicable to the corresponding bidder(s) in the manner/ formats attached to the Short Tender Call Notice at annexure-III to VI
- h. In addition to these, each bidder should also submit Declaration Certificate and No Relationship Certificate in the prescribed formats as enclosed to the Short Tender Call Notice at annexure-I to II. Without these documents the bid will be liable for rejection.
- i. Documents of valid successful bidders will be verified with the original before signing the agreement.
- j. The paving of roads shall be done on wall-to-wall basis, without leaving any soil on either side by fixing of 80mm thick cement concrete interlocking paver block of M-40 grades of approved make, design and size made by Block making machine with proper compaction conforming to IRC SP-63:2018.
- k. Defective liability period and maintenance period of the constructed roads to ensure qualitative work & good condition of road for concurrent 3 years period (i.e. from the date of the Completion of the Work. In addition to that 10 % Security deposit (2 % towards initial security deposit at the time of signing of the agreement 8 % Security deposit to be deducted from running or final bill amount to cover the maintenance period of the roads), which shall be released to the Executing Agency @ 2% at the end of 1st year after completion of the Road, @3% at the end of 2nd year after completion of the Road and @5% at the end of 3rd year after completion of the Road. 9. Any request from the tender in respect of addition, alternations, modifications, corrections, etc. or Either terms or conditions of rates of his tender after opening of the tenders will not be considered.
10. The successful tenderer shall make his own arrangement for all materials T&P machineries required for satisfactory completion of work in time. Unless otherwise specified in the conditions or contract.
11. By submitting a tender for the work, a tenderer will be deemed to have satisfied himself by actual inspection of the site and locality of the work about the quality and availability of the required quantity of materials, medical and labour and food for stuffs etc.
12. The detailed list of successful bidder against each work will be displayed in the Office Notice Board. Acceptance letter of the tender will be intimated to the successful tenderer in writing. 15. No escalation of cost in respect of labour, POL, materials & other item. If any will be entertained during the course of execution of work.
16. On no account the contract work should be assigned or subject to sublet without prior approval of Municipality, Nabarangpur and in such event the contract may be rescinded by Executive Officer, by giving a notice in writing. The contractor should be duly liable to the Municipality for any compensation payable by Municipality to any quarter and in such case the same would be recovered from the contractor.
17. The contractor should abide by the fair wages clause notified by the Government in Labour Department and in force during the period of execution and shall not pay less than the fair wage fixed by Government to the labourers engaged by him for the work.
18. The Lowest Tendered shall submit the quality test certificate report of materials used in work. as and when required.
19. The contractor will use HYSD bar rod for the reinforcement work and 43 grade OPC cement for execution of the work.
20. The department has the right to inspect the work and can reject partly or fully each structure if found defective in their opinion.

21. No claim for compensation for any damage caused by rain or any other natural calamities during the execution of work will be entertained.
22. All safety measures are to be taken by the contractor during the execution and till final completion of work by the contractor at his own cost.
23. Under no circumstances interest is chargeable to the contractor for the due or additional dues if any payable to him for the work.
24. All tender received will remain valid for period of **90 days** from the date of receipt of tender.
25. The authority reserves the right to reject or cancel any or all the Tenders without Assigning any reason thereof.
26. For detail drawing, design and specification of the work, the agency should contact the Municipal Engineer and Junior Engineer before commencement of the work.
27. In case of change of site, specification and scope of work if required during execution, the decision taken by the Municipal Engineer shall be binding on the agency and no claims will be entertained for any changes done as per site condition.
28. The agency shall not sub-let the work to any other agency for execution. However, he can appoint site in-charge / site-engineer on intimation to Municipality.
29. All Govt. dues like royalty and taxes etc. shall be deducted from the bills and will be deposited to concerned departments.
30. Nabarangpur Deposit @ 5%, I.T & GST as per Govt. norms shall be deducted from each bill.
31. No price escalation will be allowed either on material or on labour cost.
32. Regarding quality and brand of materials, the decision of the Municipal Engineer will be final and binding on the agency.
33. The agency has to follow fare wages rule of Labour Deptt. and should not pay less than the prescribed minimum wages to any labour engaged by you at the work.
34. The agency has to make light arrangement, traffic diversion, water supply etc. at site if required, at your own cost.
35. In case of use of materials like cement, bitumen, steel, paints etc, the agency has to procure it from reputed firms of approved brand and produce the bills for those materials for preparation of bills.
36. Running bills cannot be claimed as a matter of right and may be given at the sole discretion of the Executive Officer if more than 50% values of works are completed.
37. The agency has to submit weekly work programme from commencement to completion before starting the work and adjust their timing for important works like concreting and bitumen surfacing in consultation with the Municipal Engineer for better supervision and guidance.



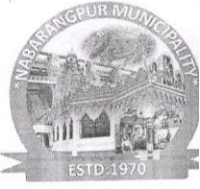
